For claim periods running to June 2021, employees will receive 80% of their usual salary for hours not worked, up to a maximum of £2,500 per month. From 1 July 2021, the level of grant will be reduced each month and you will be asked to contribute towards the cost of your furloughed employees' wages.</p> <p><b>How to access? Extended scheme with a (fourth) taxable grant calculated at 80% of 3 months average monthly trading profits, paid out in a single instalment (capped at £7,500 in total) covering the period February 2021 until April 2021 (there will be a fifth and final grant covering May to September).
